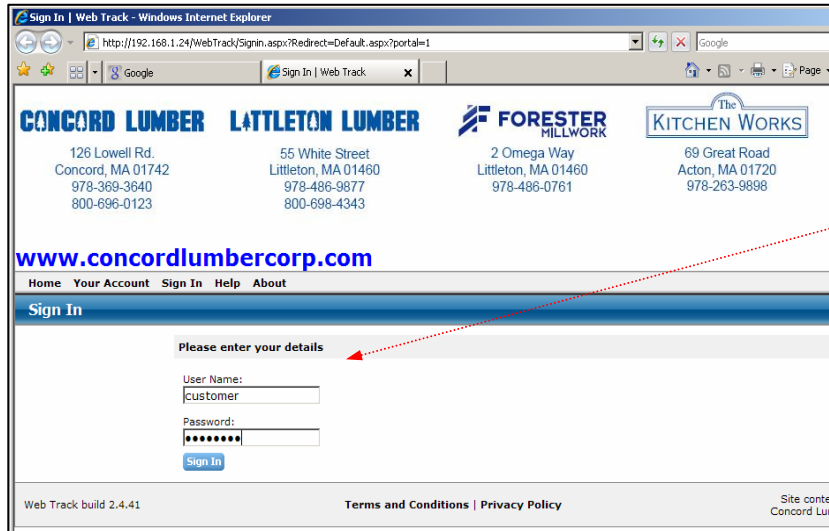


## Welcome to WebTrack, CLC's online customer interface!

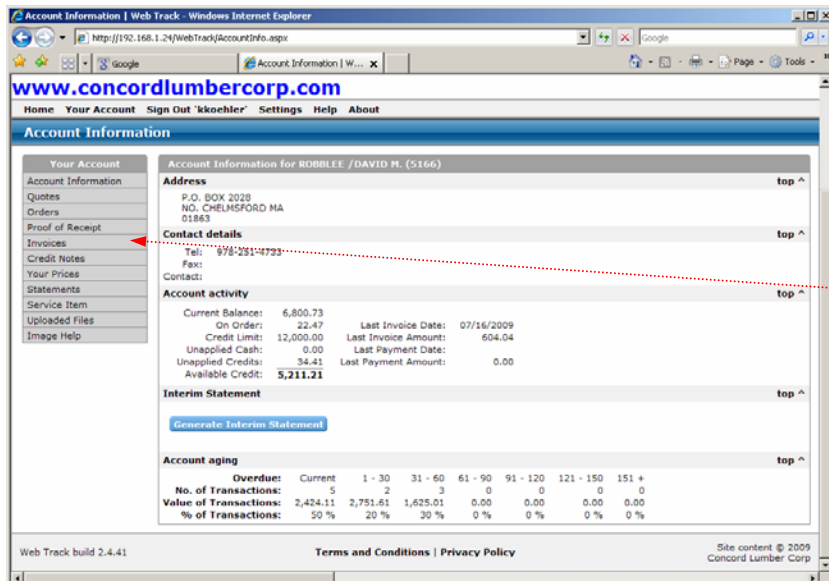
